

Host Government Agreements Overview, Discussion and Mock Negotiation

Program Description

This workshop, conducted by the Co-chairs of the recently formed Model Host Government Agreement Drafting Committee, will describe the primary types of HGAs, and solicit the audience's viewpoints on key HGA clauses such as guarantees, relinquishments, stability, decommissioning, and dispute resolution. The second segment will consist of a hands-on mock negotiation among the attendees of a host government agreement in the fictitious country of Hostgovnia.

Andrew B. Derman, Partner, Holland & Knight

Mr. Derman is a frequent teacher and lecturer at conferences, seminars and universities on oil and gas-related topics. For more than 30 years, he has taught the full scope of oil and gas contracts, including host government contracts (production sharing, concession, license and service agreements) and industry contracts (joint operating agreements, accounting procedures, confidentiality agreements, study and bidding agreements, lifting agreements, farm-in and participation agreements, unitization agreements, infrastructure contracts, LNG contracts, etc.).

Norman J. Nadorff, Special Counsel, Mayer Brown LLP

Special Counsel Norman Nadorff is located in Houston and works extensively with the Rio de Janeiro office. His practice centers on energy law and transactions and ethics law compliance.

For 30 years, Norman served as in-house counsel for major oil companies with primary focus on Latin America, West Africa and Indonesia. He was Senior Counsel for BP in Angola from 2006 to 2015 as well as Legal Manager for BP Brazil and ARCO Indonesia, where he held two expatriate assignments in the 1990's. Due to this extensive expatriate experience, Norman is adept at finding practical solutions to thorny legal issues facing foreign subsidiaries and in developing national legal departments.

Norman has dealt with a wide range of commercial contracts, including farmout, unitization, joint operating, study and bidding, EPC, drilling and wellsite services, gas sales, shareholder, joint venture, and project finance agreements, as well as a wide variety of host government granting instruments. He recently wrote a new standard Production Sharing Contract for the Energy Ministry of a country in Southeastern Africa and a detailed country report on Suriname for a major oil and gas company. Norman was worldwide Legal Manager for BP Solar in the early 2000's and also has experience with onshore US oil and gas transactions.

At ARCO, Norman wrote the Company's policies on Foreign Corrupt Practices Act, US Anti-boycott laws and US Export Regulations. He has participated in corruption, fraud, conflict of interest and hostage-taking investigations and helped resolved various commercial disputes.

Norman has been Adjunct Professor of Law at the University of Houston Law Center since 2012 and has taught International Petroleum Agreements in several US and foreign law schools. In 2006, he played key roles in the creation of a pioneering international oil and gas master's program at Angola's national law school, which is now in its sixteenth year. Norman lectures frequently in law schools and privately on petroleum law, anti-corruption laws, contract drafting and negotiations, and development of local talent.

Norman is fluent in Portuguese and Spanish, proficient in French, and has experience negotiating in all three languages. He is currently a Director of the Brazil-Texas Chamber of Commerce and a former Director of the Association of International Energy Negotiators in which he is active in several capacities, including Co-Chair of the 2022 and 2023 Model Contracts Workshops and member of the Education Advisory Board.

Asia on the structuring of an LNG Project; advising an Asian oil & gas regulatory authority in the structuring of its downstream sector, including training sessions to the agency's staff; advising a S.E.
